ORDER

THIS MATTER came before the Wyoming Insurance Commissioner upon the Stipulation of the parties, and the Commissioner having reviewed the Stipulation and being otherwise advised in the premises, hereby finds and concludes as follows:

1. That the Insurance Commissioner has jurisdiction of this matter under the Wyoming Insurance Code.
2. That this matter arose from a Petition and Notice and Order to Show Cause served upon the Respondent on September 19, 2008.
3. That the Petition alleged violation of Wyo. Stat. §§ 26-9-208 and 26-9-211.
4. That the parties have agreed to resolve this matter through a Stipulation filed herein.
5. That the Stipulation is a fair resolution of this matter and that it would be in the best interests of the parties to approve the Stipulation and thereby resolve this matter without further delay.

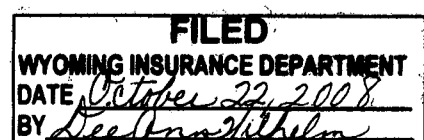
THEREFORE, IT IS HEREBY ORDERED that the terms of the Stipulation signed by the parties are accepted and approved as full and final settlement of this matter.
