ORDER WAIVING REQUIRED TWENTY DAY NOTICE FOR HEARING AND SETTING HEARING

THIS MATTER having been set for hearing on July 15, 2013 at 1:30 p.m., before James S. Mitchell, Hearing Officer, and upon Experience 1, Inc.'s Waiver of Twenty (20) Day Notice for Hearing and upon agreement of the parties the hearing will be reset for July 9, 2013 at 1:30 p.m., to consider the Form A Statement regarding the proposed acquisition of control of or merger with Founder’s Title Insurance Company (a Wyoming domestic insurance company), by Experience 1, Inc. (a California corporation). The hearing will be held in the Conference Room of the Wyoming Department of Insurance, 106 East 6th Avenue, Cheyenne, Wyoming.

In accordance with Wyo. Stat. § 26-44-103(g), the hearing shall be conducted on documents filed with the Department.

This is a public hearing open to any member of the public interested in the proposed acquisition. Any person whose interests may be affected by the proposed transaction has the right to appear and to present evidence, examine and cross-examine witnesses and offer oral and written statements and shall be entitled to conduct discovery pursuant the Wyoming Administrative Procedures Act, the hearing on July 9, 2013, will also be continued and held on July 15, 2013 at 1:30 p.m., to allow for any further public comment.

No later than the 8th day of July, 2013, all persons who expect to participate in the hearing shall file with the Department and provide to Founder’s Title Insurance and Experience 1, Inc. any supplemental information not previously provided regarding:

1. Additional witnesses expected to testify at the hearing;
2. Additional written testimony and exhibits of each witness expecting to present direct testimony;
3. A copy of any additional document, other than documents already included in the Form A filing, that will be presented at the hearing.
