**NOTICE OF HEARING PURSUANT TO
WYOMING STATUTE SECTION 26-44-103**

Pursuant to Wyo. Stat. § 26-44-103, a hearing (the “Hearing”) will be held to consider the Form A Statement (“Form A”) regarding the proposed acquisition of control of or merger with Founder’s Title Insurance (a Wyoming domestic insurance company), (“Founder’s”) by Experience 1, Inc., (a California Corporation), (“Experience 1”). In accordance with Wyo. Stat. § 26-44-103(g), the Hearing shall be conducted on documents filed with the Department.

The Hearing is hereby set for 10:30 a.m. on the 1st day of November, 2013, in the Conference Room of the Wyoming Department of Insurance, 106 East 6th Avenue, Cheyenne, Wyoming.

This is a public hearing open to any member of the public interested in the proposed acquisition. Any person whose interests may be affected by the proposed transaction has the right to appear and to present evidence, examine and cross-examine witnesses and offer oral and written statements and shall be entitled to conduct discovery pursuant the Wyoming Administrative Procedures Act.

No later than the 18th day of October, 2013, all persons who expect to participate in the Hearing shall file with the Department and provide to Founder’s and Experience 1 the following:

1. A list of witnesses expected to testify at the Hearing;
2. A summary of written testimony and exhibits of each witness expecting to present direct testimony;
3. A copy of any document, other than documents already included in the Form A filing, that will be presented at the Hearing.
